8. Consider submission of approved changes to the records to the Chief Appraiser;
9. Consider Approval of the Appraised Records for return to the Chief Appraiser per Section 41.12 of the Texas Property Tax Code and any other governing laws;
10. Discuss, consider and vote regarding policies, procedures and new forms, if any;
